Please find on the other side of this letter, the re-registration form for your child. This form is to be used only for our existing students. If you need an application form for a new student, call us and we will send you a copy with your child. You could always access the school’s website, www.iqraschool.com to download the application form, or other related materials.

Re-registration deadline is February 29th, 2012

All applications must be completely filled, signed and returned to the school with September fee and the post dated cheques no later than Wednesday February 29th, 2012

Without such payment, the school cannot guarantee you a space for your child. Please note the deadline for re-registration will not be extended. Students, who submit their re-registration after the deadline or without September’s fee and the post-dated cheques will be put on our waiting list and have to pay **\$200.00 registration fee** (will be treated as a new applicant.) To provide your child with quality education, and in order for us to devote all our time, efforts and energy toward teaching and improving the school, we would like to notify you of the **followings important notes:**

1. The registration of your child will not be confirmed unless you give the school September fee and nine post dated cheques, the first one to be dated October 01st, 2012 and the last to be dated June 01, 2013. These cheques must be included with this form, please.
2. In order to qualify for the **5% discount**, parents paying full fees by first week of September 2012 will get a rebate of **5% on tuition fee only.**
3. We charge \$25.00 for any NSF (No Sufficient Fund) returned cheque. Please inform the office a week in advance to avoid any NSF charges. Furthermore, if the bank returns your cheque more than once, you will be required to pay the full remaining amount for the entire year in cash, certified cheque, or money order.
4. September fee for next year **will not be refunded** if you decide to pull your child/ren out of the school after June 29th, 2012.

Thank you for choosing IQRA Islamic School as another home for your child/ren, and we hope to meet or exceed your expectations.
